CHAPTER I INTRODUCTION

1.1 Background of the Study

English is the first foreign language taught as a compulsory subject in junior high school, senior high schools, and universities in Indonesia. Speaking, writing, listening, and reading skills in English are needed to be mastered when student's learn a foreign language can understand when taught via online.
